

Privacy Policy

Yin for You recognizes that your privacy is very important, and we take it seriously. The Privacy Policy applies to both our website (www.yinforyou.com), and our services. This privacy policy describes our policies and procedures about the collection, use, disclosure, and sharing of your personal information or personal data when you use the Yin for You website or subscribe to/use our services.

The information we collect

We collect information directly from individuals, and automatically through the use of our services.

The information we collect directly from individuals includes:

- email-address
- name
- any other information provided

How we use the information

We use the data we collect in the following way:

- *Email-address:* To address your questions and to send you our newsletter if you have requested so. You can 'unsubscribe' at any time below every email.
- *Name:* To personalize our emails to you
- *Any other information provided:* We only use such information if it is necessary to address your question and/or to improve our services to you and/or to comply with legal or regulatory requirements

Who has access to your data

Yin for You does not sell, trade, or rent personal data to third parties. But there is data that we will need to share with third-party service providers -i.e. "Data processors." These third parties act as Data Processors within the meaning of the relevant privacy legislation.

- *Website Hosting:* Our hosting provider hosts your data in the Netherlands.
- *Emails Service:* We use Email marketing software to manage our emails and your data.
- *Government agencies:* If we are legally obliged to do so, we must pass on your details to government agencies, for example to the tax authorities.

How long do we keep your data

Your personal data will be kept for as long as this is strictly necessary for the purposes that were described above in this privacy policy.

Are you aware of your rights

If and when we process your personal data, you still remain the owner of your data. Therefore, you have the right to do the following:

- *Access your Information:* You can request information at any time from us about data from you that we have stored.

- *Deletion:* You can request at any time from us that we delete your personal data.
- *Rectifying:* You can request at any time from us that we rectify or supplement your personal data if you believe that this personal data is incorrect (or incomplete).
- *Data portability:* In the event that we process your personal data digitally, you can request at any time the transfer of your personal data.
